# Billy C. Hamilton Executive Vice Chancellor and Chief Financial Officer Texas A&M University System

Billy Hamilton is Executive Vice Chancellor and Chief Financial Officer of the Texas A&M University System. TAMUS is one of the largest systems of higher education in the nation, with a statewide network of 11 universities, seven state agencies, two service units, and a comprehensive health science center.

Prior to his current position, Hamilton was a consultant in tax, fiscal policy, and related issues. In this capacity, he works with a wide range of public and private clients. He continues to write a regular column on state tax issues for the national publication *State Tax Notes*.

Prior to January 2007, Hamilton was Chief Deputy Comptroller of Public Accounts of Texas. He was appointed to that position in January 1999 by Comptroller Carole Keeton Strayhorn. Hamilton previously served as Deputy Comptroller for seven years from 1991 to February 1998. In the interim, he was in private practice. As Deputy Comptroller, Hamilton was responsible for the day-to-day management of the Comptroller's office. Hamilton retired from state service in late 2006.

Hamilton has also served on special assignment as Co-Executive Director of the California Performance Review for Governor Arnold Schwarzenegger. The CPR's 2,500 page assessment of California government, *A Government for the People for a Change*, was released in July 2004.

Prior to joining the Comptroller in 1991, Hamilton was director of state and local services for the Policy Economics Group of KPMG Peat Marwick in Washington, D.C. He served in that position from 1987 through 1990. In 1986-87, Hamilton was executive director of the Select Committee on Tax Equity, a panel created by the Texas Legislature to study the state's tax structure. Prior to his work with the Select Committee, Hamilton worked for the Texas Association of Taxpayers, a business group interested in tax policy and fiscal responsibility in Texas government. From 1982-86, Hamilton was Associate Deputy Comptroller for Fiscal Management and Chief Revenue Estimator with the Comptroller of Public Accounts. He was also research director for the Comptroller.

Hamilton is past president of the national Federation of Tax Administrators and the National Tax Association. He has served on the board of directors of the Federation of Tax Administrators, the Multistate Tax Commission, and the National Tax Association. He has served as a member of the board of directors of Quality Texas and also served as a board member of the national Electronic Benefits Council. He was the first recipient (1998) of the Bob Bullock Award for Public Stewardship. He is a fellow of the National Academy of Public Administration.

Hamilton is a graduate of The University of Texas at Austin and the Lyndon B. Johnson School of Public Affairs. He was recognized as the first recipient of the LBJ School's Distinguished Alumni Award in 1987.

# Kevin P. Reilly, Ph.D. President Emeritus and Regent Professor, University of Wisconsin System Senior Fellow, Association of Governing Boards of Universities and Colleges

Dr. Kevin Reilly is President Emeritus and Regent Professor with the 26-campus University of Wisconsin (UW) System, having served as president from 2004–2013. In collaboration with the UW Board of Regents and the Chancellors, he developed the "Growth Agenda for Wisconsin," a long-term vision and strategic framework for what the university needed to do to help Wisconsin and the nation be more competitive in the global knowledge economy. Under his leadership, enrollment grew to 182,000—an all-time high—and sponsored research continued to expand beyond \$1 billion annually.

Reilly served as Chancellor of UW-Extension from 2000 to 2004 and as Provost and Vice Chancellor of Extension from 1996 to 2000. A native of New York City, he came to Wisconsin from the State University of New York (SUNY) System, where he was Associate Provost for Academic Programs and then Secretary of the University. In the latter role, he was the corporate officer staffing the SUNY Board of Trustees.

He is currently a member of the Higher Education Working Group on Global Issues for the Council on Foreign Relations and the Steering Committee for the Celtic Studies Program at UW-Madison. He has also served as the President of the National Association of System Heads.

He is author and editor of books and articles on higher education leadership, policy, and accreditation, among other topics in literature and Irish studies. Among his awards and honors are the Signature of Excellence Award from the University Professional & Continuing Education Association, the Chancellor's Medallion from UW-Oshkosh, and a commendation from the Senate of Wisconsin for his contributions to the state.

Reilly earned his B.A. at the University of Notre Dame and his M.A. and Ph.D. at the University of Minnesota.

# Timothy M. Renick, Ph.D. Senior Vice President for Student Success and Professor of Religious Studies Georgia State University

Dr. Timothy M. Renick is Senior Vice President for Student Success and Professor of Religious Studies at Georgia State University. At Georgia State, he has served as Chair of the Department of Religious Studies and Director of the Honors Program. Since 2008, he has directed the student success and enrollment efforts of the university, overseeing among the fastest improving graduation rates in the nation and the elimination of all achievement gaps based on students' race, ethnicity, or income level. He currently is principal investigator for a \$9 million U.S. Department of Education grant to study the impact of predictive-analytics-based advisement on ten-thousand low-income and first-generation students nationally.

A *summa cum laude* graduate of Dartmouth College, Renick holds his M.A. and Ph.D. in Religion from Princeton University.

# Richard M. Rhodes, Ph.D. President and CEO Austin Community College District

Since joining the Austin Community College (ACC) District in September 2011, Dr. Richard Rhodes has worked to improve pathways into higher education, strengthen awareness of the community college mission, and give students the tools to accomplish their educational, professional, and personal goals.

#### The Honorable Kel Seliger Senator, Texas Senate, District 31 State of Texas

Kel Seliger was first elected to the Texas Senate in 2004. Senate District 31 spans 37 counties from the Panhandle to the Permian Basin and includes Amarillo, Midland, Odessa, and Big Spring.

Born in Amarillo and raised in Borger, Senator Seliger is a graduate of Borger public schools and Dartmouth College. He spent 35 years in the steel industry.

Senator Seliger currently serves as Chairman of the Senate Higher Education Committee and is a member of the Senate Education Committee, Senate Finance Committee, and Senate Committee on Natural Resources and Economic Development.

Senator Seliger has been recognized by many groups for his conservative principles as well as his dedication to small government and local control. He has been named a Fighter for Free Enterprise by the Texas Association of Business four times for his steadfast support of policies that encourage and promote a healthy business climate in Texas. Seliger is privileged to be the recipient of the Texas Municipal League Legislator of the Year Award, Texas Conservative Coalition's Conservative Champion Award, Texas Association of Counties Friend of County Government Award, Texas Wildlife Association's Conservation Hero Award, the Conservative Roundtable of Texas' Effective Conservative Lawmaker, and the Texas Parent Teacher Association Legislative Honor Roll.

During the 85th Legislative Session, as Chairman of the Senate Higher Education Committee, Senator Seliger secured an additional \$1.07 million in funding for The University of Texas of the Permian Basin (UTPB) College of Engineering, which will be used to expand the chemical and electrical engineering programs. Additionally, \$4.2 million is provided to UTPB as a hold harmless, to ensure the school does not lose more than 10 percent of its state funding. Senator Seliger also succeeded in securing \$4.17 million for Texas Tech University's future Veterinary Medical School.

As part of his continued service on the Education Committee, Seliger authored Senate Bill 463, a bill that extends the option of Individual Graduation Committees for students who passed all of their courses but failed to pass up to two state-mandated tests.

Chairman Seliger and Representative John Smithee championed House Bill 1463 to reduce frivolous lawsuits and aggressive shake-down tactics related to the Americans with Disabilities Act that harm small business in Texas. Together Smithee and Seliger also passed Senate Bill 654, which will help improve access to health care in rural and medically underserved parts of Texas.

Prior to his election to the Texas Senate, Senator Seliger served four terms as Mayor of Amarillo and as a member of the Amarillo City Commission and the Amarillo Civil Service Commission.

He and his wife Nancy reside in Amarillo, and have two sons, Jonathan and Matthew.

Mary Sherwood, Ph.D. Regent Del Mar College
