



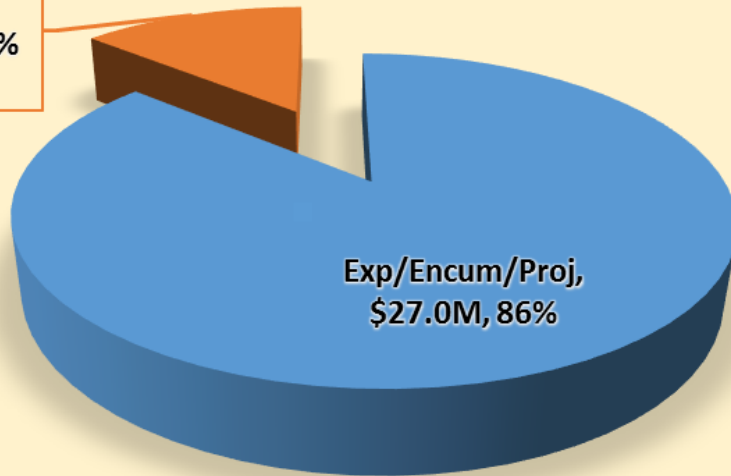

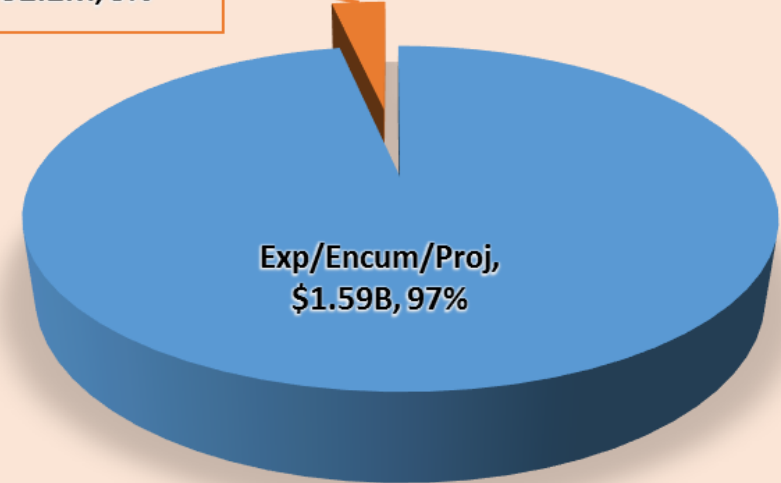
Operating Strategies (A&B) Budget

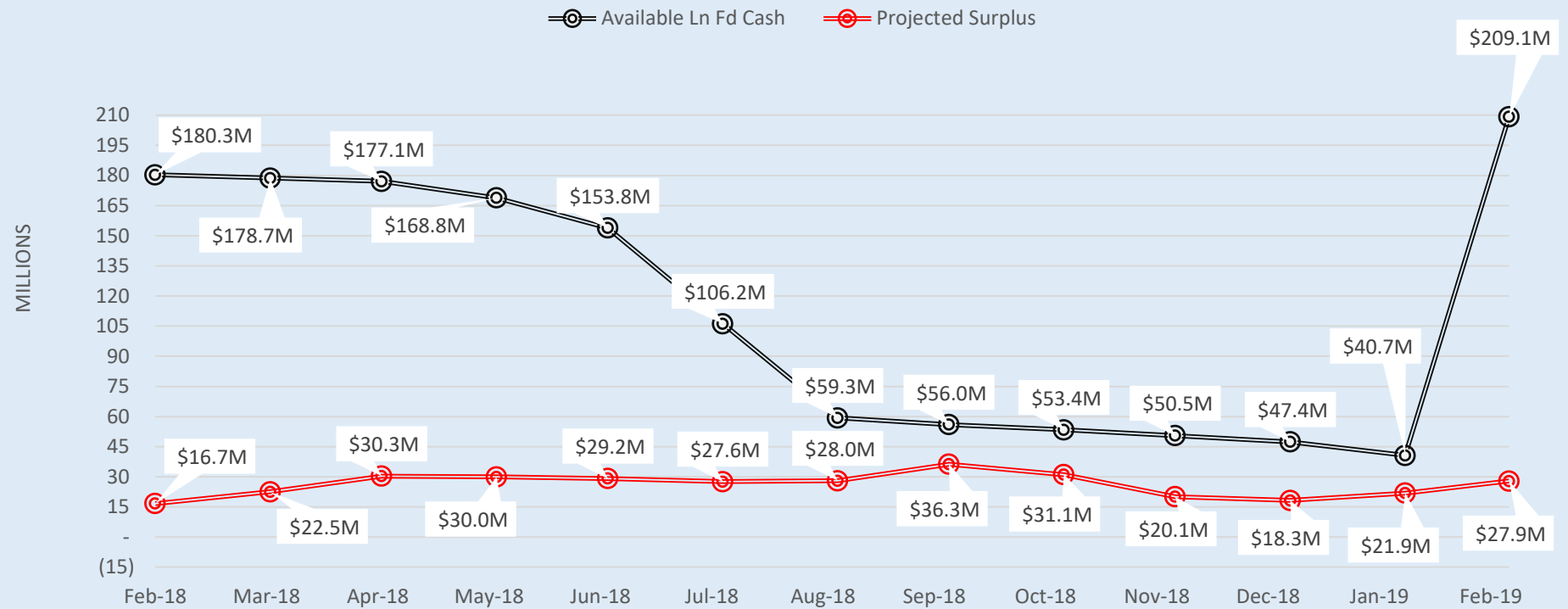

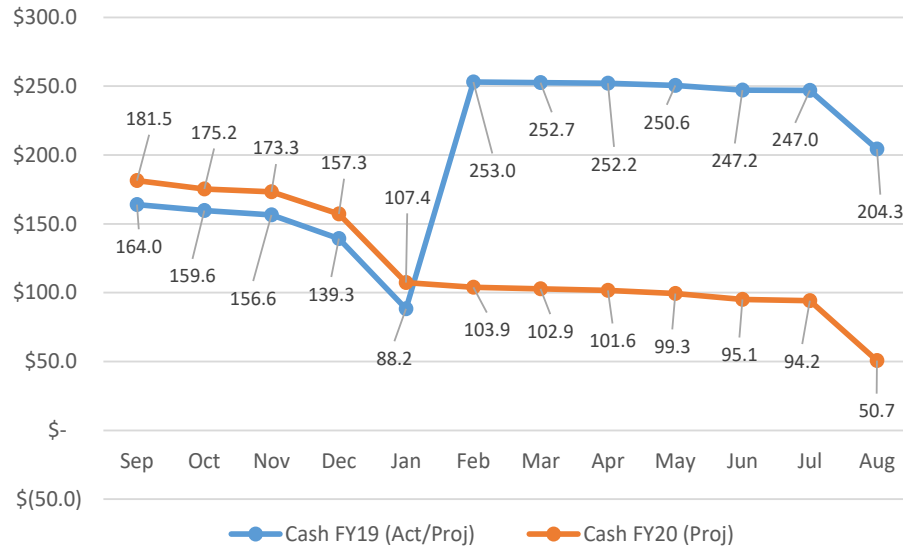

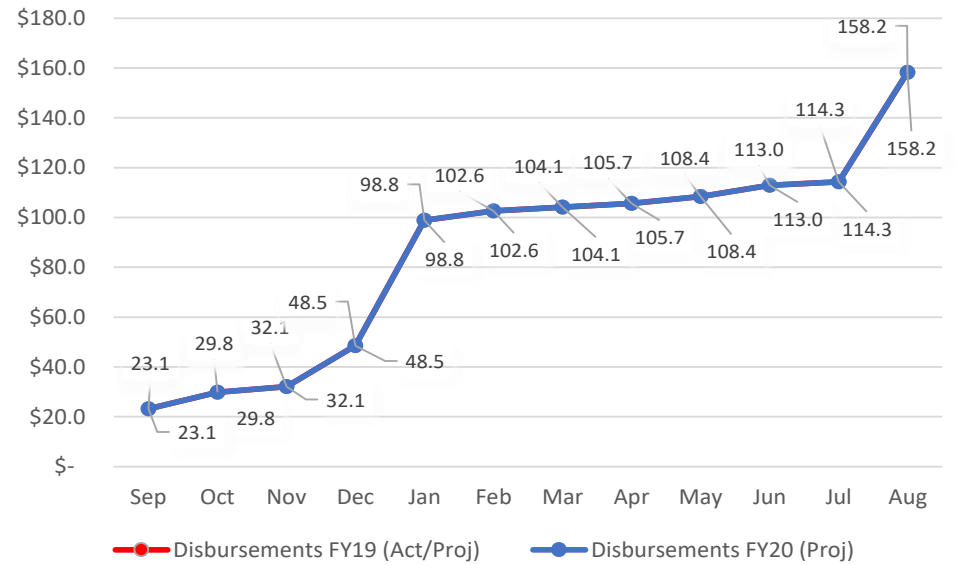
