### **Current Policy**

An institution with an existing Doctor of Nursing Practice program is required to submit a proposal for approval by the Board to offer a BSN-to-DNP pathway for students.



## Rationale for Considering Revision

- Entry to DNP programs is beginning to change
- Nationally, about 40 percent of DNP programs now offer the BSN-to-DNP pathway
- Texas could benefit from having BSN-to-DNP pathways available for students
- For some students, this would allow a more efficient, less expensive pathway to the DNP

#### Proposed Revised Policy

Allow institutions with strong, existing master's-entry Doctor of Nursing programs to submit proposals to offer the BSN-to-DNP pathway for approval by the Commissioner.



## Rationale for Policy Revision

- Institutions with existing programs have been asking for the BSN-to-DNP pathway
- In 2014, Board staff met with Deans of the DNP programs
- BSN-to-DNP pathway be considered without Board approval required if they met certain conditions:
  - Existing DNP program has consistent or increasing enrollment
  - Existing DNP program has successful completion rates
  - Existing DNP documented student demand
  - Curriculum plans for full-time and part-time students

### Additional Information

BSN-to-DNP programs offered by Texas private institutions are expensive

~\$90 - \$120K for a 3 to 4 year program (tuition and fees only)

Higher cost and longer time for students to first complete an MSN in Nurse Practitioner and then complete their DNP

 $\sim$ \$60,000 for MSN and  $\sim$ 2 years, plus  $\sim$ \$60,000 for DNP and  $\sim$ 3 years



## **Additional Information**

- Texas students are entering private institutions to pursue the BSN-to-DNP
- Texas students are also enrolling in out-of-state programs that offer the BSN-to-DNP
