ADMINISTRATOR'S STATEMENT

The Board of Trustees of the Paris Junior College District is composed of nine members all of who reside in Lamar County in Paris and serve six year terms. The members of the board and their terms are as follows:

Jim Bell, 2014-2020; Ginna Bowman, 2012-2018; Mark Buster, 2017-2018; Curtis Fendley, 2012-2018; Berdie Gibson, 2016-2022; Carolyn Lockett, 2016-2022; Charles Lynch, 2014-2020; Louise Taylor, 2016-2022; Clifton Wilkerson, 2014-2020.

SIGNIFICANT CHANGES IN POLICY:

There are no significant changes in policy which impact this budget request.

SIGNIFICANT CHANGES IN PROVISION OF SERVICE:

Paris Junior College continues its focus on Guided Pathways and partnerships with K-12. The college focuses on retention of students, student success and assurance that students graduate on-time, without extra hours and with identifiable marketable skills.

With the implementation of Guided Pathways the college has employed Student Success Coaches assigned to every student enrolled. Success Coaches track milestones for each of their students to help them stay on path and to identify when additional support is needed. The college has also implemented software to help in the retention efforts.

The college serves five and one-half counties with a tax base made up of Lamar County. In November, 2016, residents in Lamar County voted to join the Paris Junior College District expanding the taxing district historically limited to the City of Paris.

Paris Junior College embraces 60X30TX and understands that the future of our region depends upon having a trained workforce.

SIGNIFICANT EXTERNALITIES:

The educational attainment of this area is lower than the state and national averages. Two of the five and one-half counties served are among the ten poorest counties in the State of Texas. The college deals with a student population majority consisting of first generation college students. The college works to change a culture in the area of devaluing education.

The college provides dual credit to 28 independent school districts and two private schools. The college does significant work with industries through the Skills Development Fund. Enrollment has declined over the last six years due to the economy picking up and the unemployment rate dropping to all-time lows. The college works with multiple Economic Development Corporations to help recruit new industry to the region.

The college's service area covers 3,848 square miles and there are extension centers in Greenville and Sulphur Springs. Paris Junior College works with the industry in Hunt and Hopkins County to assure a trained workforce.

• Continuing to expand CTE dual credit offerings in the Upper East Texas area.


• Continue to use Student Success Coaches to mentor students and assure the success of Guided Pathways.
