The District is facing financial challenges in the coming years that will greatly impact the District's ability to educate and serve the citizens of our service area. With additional support from the State of Texas, Lee College will make the following investments:

- Dual Credit Expansion
- Weekend College Expansion
- Upgrade Technical Education Equipment
- Expand Student Support Services


