Located in the North Houston metro area of Texas, we serve 1,400 square miles in Harris and Montgomery Counties.

Our student enrollment is approximately 80,000 in credit classes and 14,000 in Career & Technical Education and community/leisure continuing education.

Lone Star College is the largest institution of higher education in the Houston region, one of the largest community colleges in Texas and the fastest growing community college in the United States. Lone Star College System includes six comprehensive college campuses:

- Lone Star College–CyFair
- Lone Star College–Kingwood
- Lone Star College–Montgomery
- Lone Star College–North Harris
- Lone Star College–Tomball
- Lone Star College–University Park

We have five satellite centers:

We offer the following:

Our tax rate is 12.10 cents per \$100 valuation. The first \$5,000 or 1% of appraised value, whichever is greater, of owned and occupied residential property is exempt.

Also exempt: the first \$75,000 of a resident property owned and occupied by a person over 65 years old. Taxes are frozen at 2006 amounts for person 65 or older or disabled.

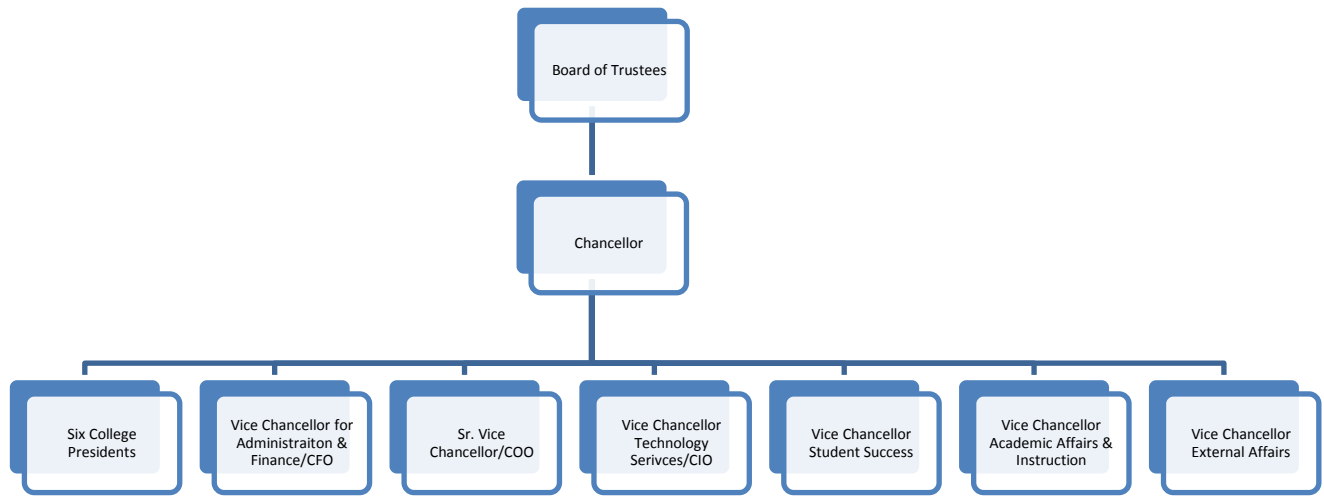
