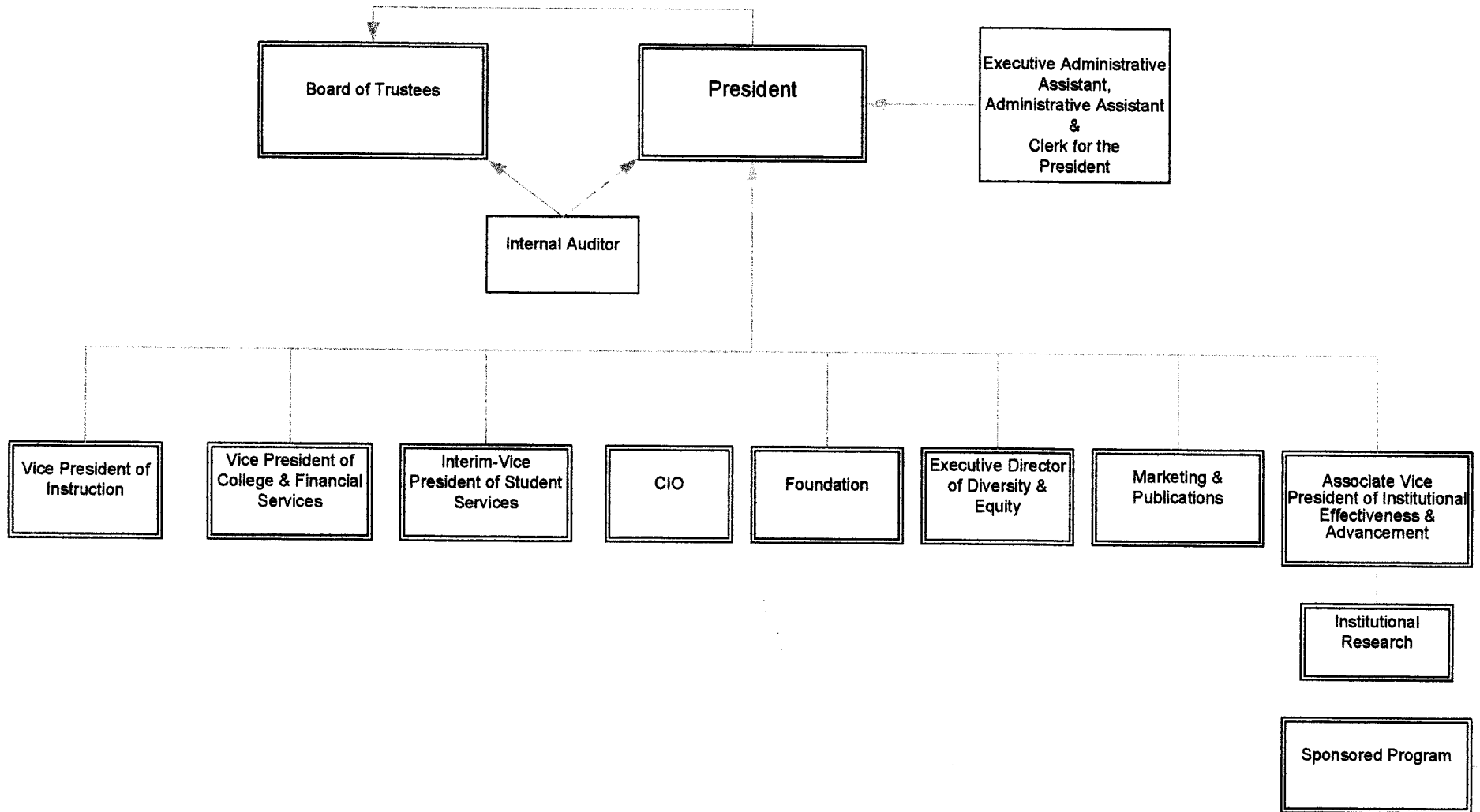

College of the Mainland community college district strongly endorses the additional formula request that was made on July 31, 2008, by the Texas Association of Community Colleges.

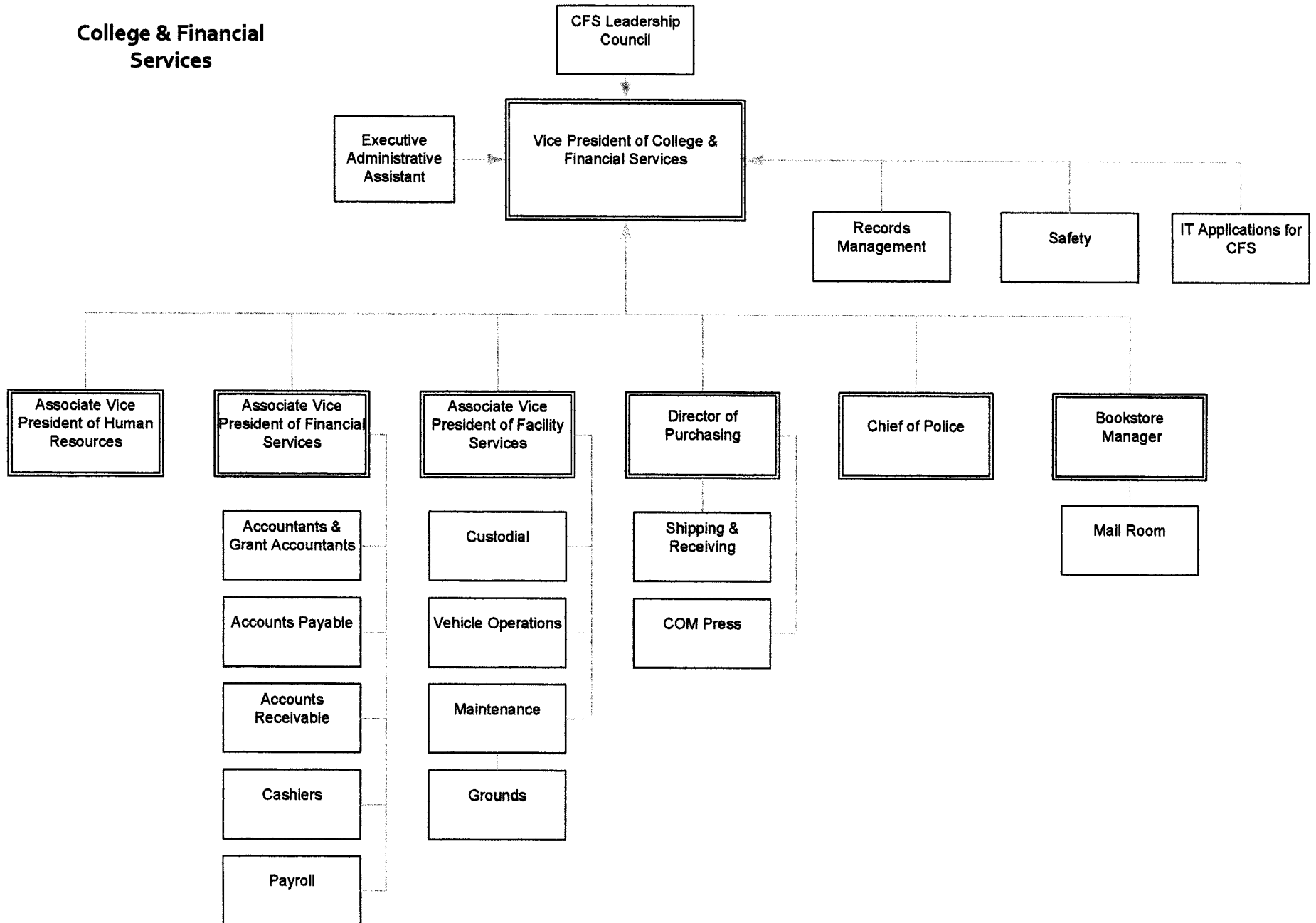

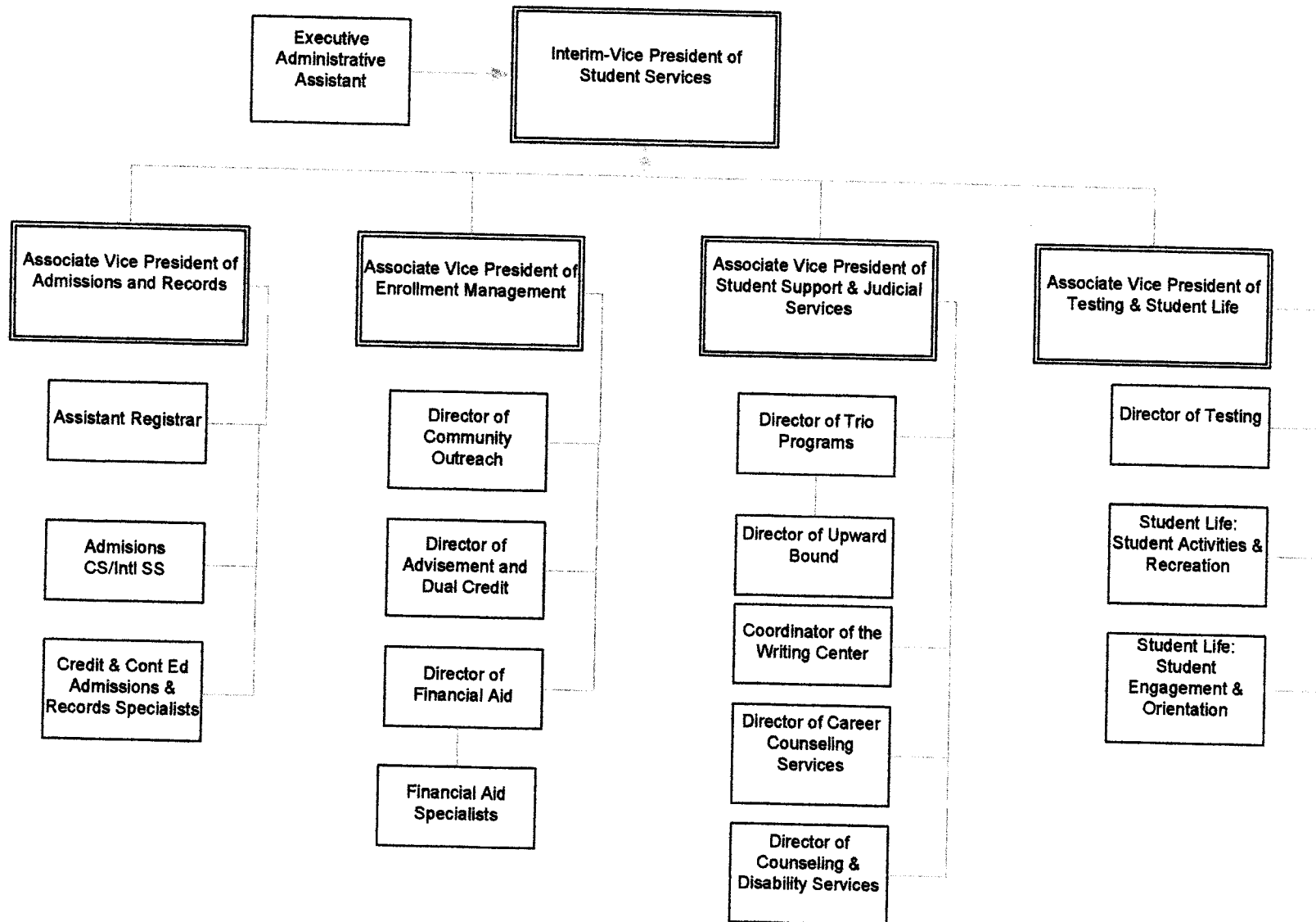
