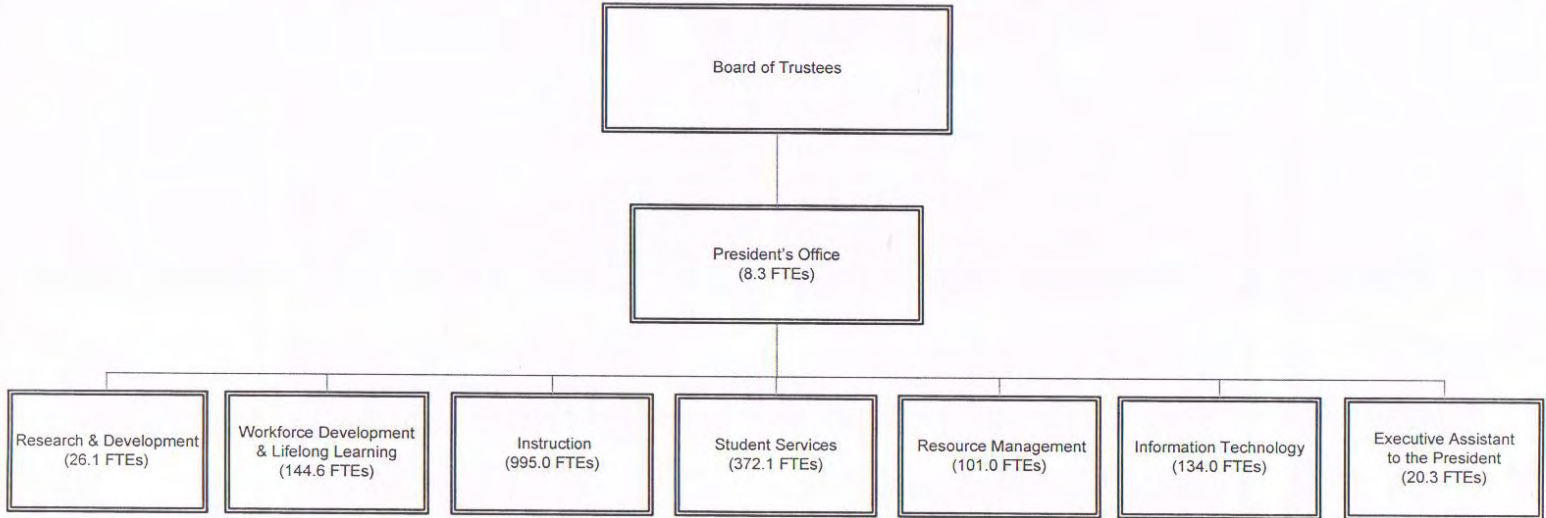

# El Paso County Community College District - Organizational Chart










