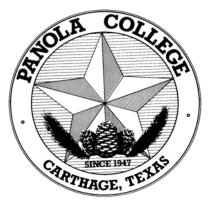

Panola College supports the \$1.8 billion formula funding request that was outlined in the letter from the Texas Association of Community Colleges on July 28, 2016. With additional support from the State of Texas, Panola College will make the following investments:

\*Dual Credit Expansion

\*Redesign learning & academic support system

\*Instructional Technology to enhance student learning outcomes

\*Upgrade recruiters and admissions staff to advisors to bridge the gap between high school and college

\*Upgrade campus safety

Panola College is focused on providing services to students to help the state meet the goals set forth in the 60x30TX higher education strategic plan. The College is also investing heavily in academic and student support services to assist students in selecting a pathway and graduating on time. This includes financial literacy help and counseling to help students graduate with little or no debt. The College is training its peace officers in preparation for the new campus carry law to go into effect in 2017. Finally, the college is updating its overall campus safety and security plan, including upgraded security cameras and additional notification systems.
